FOREWORD

Under the Decade of Centenaries programme, Kerry County Council contracted Thomas Dillon as a Historian-in-Residence in January 2020 for a three-month period. One of the main objectives outlined for the residency was to produce a comprehensive list of sources, focusing in particular on the Irish War of Independence.

The holdings of various repositories all over the world in relation to the history of County Kerry during this period - and the years leading up to and after the conflict - have been gathered together in this list.

From manuscripts, letters, photographs and museum artefacts to books, folklore, newspapers and the military, pension and compensation records of individuals - the range of sources is diverse and seeks to represent many different perspectives.

Sources are an important link to the past and play a key role in understanding the events of times gone by. It is hoped this resource will be a useful tool for historians and the general public for research purposes and that it will further promote an interest in exploring the events of this important period in the history of Kerry.

Cuireadh bailiúcháin le chéile sa liosta a bhaineann le stair Contae Chiarraí i rith an tréimhse seo - agus ins na blianta roimh agus i ndiaidh na coimhlinte - as taisclanna éagsúla ó gach cearn den domhan.

Letter to Hugh de Fellenberg Montgomery, Fivemiletown, Co. Tyrone, from John E Walsh, Hon Sec. of the Southern Unionist Committee, Dublin, 10th June 1918, commenting on the ballot return of the meeting of the 7th June, '... it is splendid, and we feel that we are much indebted to you and Sir James Stronge for the help and advice you have given us, in achieving this result.

'The next thing we have to consider is the co-option meeting of the Executive, which will be held in the near future. Among the Presidents and Vice-Presidents we are in a minority: among the Representatives we have a slight majority, and of the elected element our majority is 16 to 4. It is accordingly of importance to strengthen the Representative element as far as possible before the meeting.

'Six counties have no Representative. East Wicklow and Limerick have now elected their Representatives, both of whom are strong supporters. Kerry, Kilkenny, Antrim, and King's County are still without Representatives, and I am trying to arrange with them to have their Representatives elected at once, ...'

May I express the hope that you will see your way to oppose the arming of the Nationalist Volunteers for "Home Defence", a course which the newspapers suggest is in contemplation. They are anxious to be armed and legalised merely as a preparation for the introduction of Home Rule. ...'

14th May 1916, District Inspector F. Britten, Typed copy of a statement concerning the circumstances under which Daniel J. Bailey gave District Inspector Britten a statement on 23rd April 1916.

"..... I received a message at Tralee from Sergeant Restrict that the prisoner who had been arrested as David Mulcahy had some important information"

"I went in to see the prisoner Sergeant Restrict went in with me at first but left us alone later"

"I introduced myself to the prisoner and he at once began to tell me who he was, viz., Daniel J. Baily and that he was one of the three who landed from a German submarine on Friday morning He asked me to guarantee him protection and I told him I would; this I took to refer to, and am sure he meant it to refer to, protection from violence from Sinn Fein adherents He then asked me if I would guarantee him from punishment I told him it was not in my power to do so. He then appeared to hesitate about telling me his story and again impressed upon me the importance of his information He then told me that a Wilson Liner which had been captured by the Germans at the beginning of the War was to be pilotted into Fenit on Monday that she had on board 20,000 arms over 1,000,000 rounds of ammunition, 10 machine guns (two ready for action) and a number of bombs and explosives; that simultaneously there was to be a general rising in Ireland on Monday and he made some mention of Dublin Castle being attacked or raided"

"I knew at this time that a vessel, supposed to contain these arms and ammunition had been lying off Fenit and that she had later been chased and sunk"



"Before giving me the statement, he asked me on my honour not to publish it whilst he was there or in that part of the country. (I told him again to refer to the danger he would be in if it were known by the Sinn Fein element that he had turned informer) He appeared most anxious to get away from his present surroundings."

"I did question him as to present whereabouts of Monteith and whether he knew anything of the part taken in the movement by prominent Sinn Feiners in Ireland, but he would throw no light on these points.

When I asked him how he knew of the landing of the arms and the general rising, etc., he said he had overheard it from scraps of conversation when on the submarine."

"..... I sent out an escort by motor to bring him to Tralee for his greater safety. He arrived there and remained at Tralee till Tuesday, when he was sent under escort to Queenstown."

CO 762 IRISH DISTRESS COMMITTEE

In 1922, the Irish Distress Committee, later reconstituted as the Irish Grants Committee (March 1923), was set up in London to aid refugees from Ireland, but later extended its activities to granting loans to persons having valid claims against either Government. Its work was charged with the responsibility of discovering whether any further action with regard to persons who had suffered injury to person or property in Ireland since 11th July 1921 was necessary. The recommendations of this Committee (Cmd.2748) led to the appointment of a second Irish Grants Committee in October 1926 with wider terms of reference which laid special emphasis on the plight of loyalists in Southern Ireland who had suffered hardship or loss between 11th July 1921 and 12th May 1923. This latter Committee sat until 11th February 1930 when its report, signed by its chairman, Wood-Renton, was sent to the Secretary of State for the Dominions. Certain claims were still being dealt with as late as 1933 but attempts to get the Committee re-constituted proved abortive.

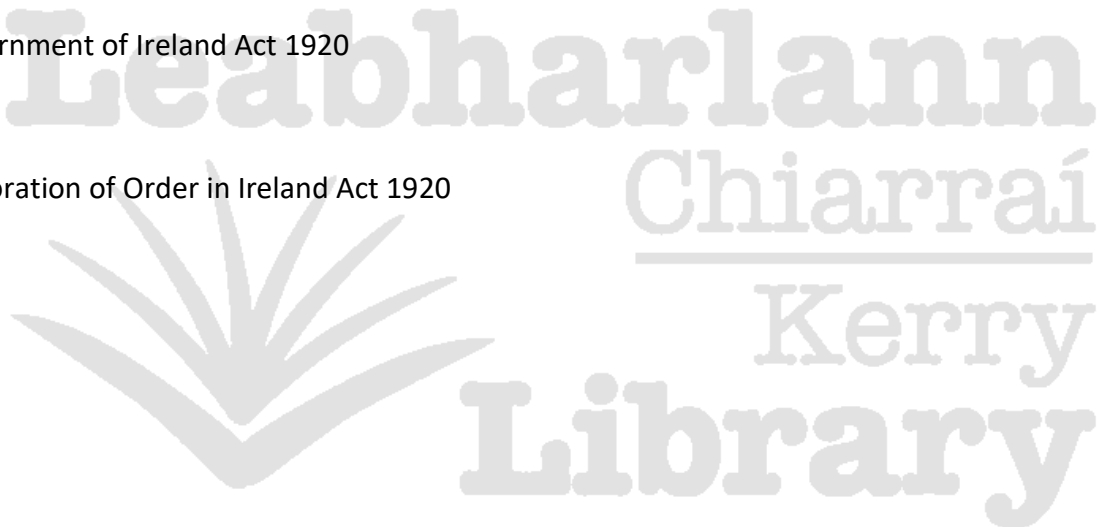

The British Army World War I Service Records are War Office (WO) records also known as the WO363 records and the 'Burnt Documents.' In 1940, during WWII, there was a bombing raid on the War Office in London where the records were held. During this raid, a large portion (approximately 60 per cent) of the 6.5 million records was destroyed by fire. The surviving service records have become known as the 'Burnt Documents'. They are digitised and available to view on Ancestry.

BRITISH ARMY WWI MEDAL ROLLS INDEX CARDS, 1914-1920

The Medal Index Cards collection is the most complete listing of individuals who fought in the British Army in WWI, containing approximately 90% of soldiers' names.

The Index Cards were created in order to keep in one place details about a soldier's medal entitlement. Database compiled from the Army Medal Office. WWI Medal Index Cards, in the care of the Western Front Association.

UK, WWI PENSION LEDGERS AND INDEX CARDS, 1914 - 1923

Each of the original volumes represented one or more regiments, corps or other units of the British Army.

Every year, each ship registered in Ireland had to submit a report to the Registrar General of Shipping and Seamen (RGSS), which was responsible for keeping the records for the Merchant Navy. The records are extensive and provided detailed information regarding each crew member. Crew members were not only from Ireland but also from around the world. You will find natives of Norway, Russia, Sweden, America and Germany, to name a few.

IRELAND MILITARY PENSIONS AND MEDALS 1916 - 1922

Ireland military pensions and medals 1916 - 1922 has been created from the records held by the Military Archives in Dublin. The records come from the Military Service Pension Collection (MSPC) and Medals Series.

IRELAND, BRITISH ARMY OFFICERS 1914 - 1918

It also provided lists of deserters and absentees from Britain's armed forces. During the First World War, these lists were produced as a supplement every fortnight.

This collection has been obtained from the British Red Cross website.

BRITISH RED CROSS REGISTER OF OVERSEAS VOLUNTEERS 1914 - 1918

Records of those who volunteered overseas with the British Red Cross during World War I. You can find out where individuals worked, passport number and their department.

At the start of the First World War, the British Red Cross joined forces with the Order of St. John Ambulance to create the Joint War Committee to assist with medical care in the field.

Therefore, the register includes men and women who worked with the Voluntary Aid Detachments, Scottish Women's Hospital, Order of St. John and many more.

Women played a significant role during the Great War through their involvement with these voluntary organisations.

IRELAND, DUBLIN METROPOLITAN POLICE GENERAL REGISTER 1837 - 1925

The records in this collection are from the Dublin Metropolitan Police's general register comprising recruitment and transfers within the police force from 1837 to 1925.

While the register was used up until 1975, due to data protection reasons, only the entries up to 1925 have been digitised and made available. Jim Herlihy's book *The Dublin Metropolitan Police: A Complete Alphabetical Listing of Officers and Men, 1836-1925* provides an alphabetical listing of the general register.

In 1836, the Dublin Metropolitan Police, alongside the Irish Constabulary (later, the Royal Irish Constabulary), was established. These two organisations replaced the County Constabulary.

After the truce of July 1921 following the War of Independence, the Royal Irish Constabulary disbanded and the Civic Guard (later named Garda Síochána na hÉireann) was established. In 1925, the Dublin Metropolitan Police merged with An Garda Síochána.

IRELAND, ROYAL IRISH CONSTABULARY PENSIONS 1826 - 1925

This unique collection of Royal Irish Constabulary (RIC) records comes from the National Archives, Kew. It consists of the records for pensions and allowances given to officers, men and staff of the RIC and their widows and children.

In the records, you will find registers of pensions along with registers of deceased pensioners and pensions paid when the RIC was disbanded in August 1922.

This collection comprises The National Archive (TNA) series PMG 48: Royal Irish Constabulary Pensions, etc. Piece 2 of this series is missing.

IRELAND, DUBLIN METROPOLITAN POLICE PRISONERS BOOKS 1905 - 1908 AND 1911 - 1918

The entries are handwritten and include the details of daily charge sheets. Each volume contains an index of prisoners with references to the pages containing details of the charge.

IRELAND, NATIONAL ROLL OF HONOUR 1914 - 1921

This collection of transcripts has been created from all known available references and collections for Irish casualties published before 1922. They include Soldiers Died in the Great War, Ireland's Memorial Records, The Commonwealth War Graves Commission, newspaper items, articles and books. The material has also been cross referenced with the 1901 and 1911 Census to provide a more precise list of Irish casualties than was previously available to family historians.

IRELAND, PETTY SESSIONS COURT REGISTERS

The Petty Sessions were the lowest courts hearing cases about money owing, domestic disputes and public order offences. The originals are held at the National Archives of Ireland.



IRELAND, ROYAL HIBERNIAN MILITARY SCHOOL STAFF AND PUPILS 1847 - 1932

There are over 9,000 transcripts in this record set, which is comprised of two collections: admissions registers 1847 - 1932 and a staff list for 1864.

PASSENGER LISTS LEAVING UK 1890 - 1960

The passenger lists in BT27 include long-haul voyages to destinations outside Britain and Europe.

While countries such as Australia, Canada, India, New Zealand, South Africa and USA feature strongly, all continents are covered and you will find passengers on ships sailing to all parts of Asia, the Caribbean, South America and West Africa, even to remotest oceanic islands such as South Georgia Island.

These voyages often called en route at additional ports, including those in Europe, and any passengers disembarking at these stops are included. Voyages from all British (English, Welsh and Scottish) ports, and from all Irish ports before partition in 1921 and all Northern Irish ports after partition, are covered in BT27.

EASTER RISING & IRELAND UNDER MARTIAL LAW, 1916 - 1921

Created in partnership with The National Archives in London, this collection contains 91 pieces from their WO35 series, War Office: Army of Ireland: Administration and Easter Rising Records.

WO35/69 - EVENTS OF EASTER RISING WEEK



This piece includes military intelligence reports on the actions of the rebels as well as reports of unarmed persons killed or wounded by the rebels throughout the week of the Easter Rising. The records include details of how individuals were wounded. It also includes daily situation reports created by the British Army.

This piece includes telegrams reporting the swift trials and executions of prominent leaders of the Rising. The administration reports include discussions about what to do with the possessions of prisoners. For example, one report explains that Padraig Pearse's mother had requested that her son's watch and money be returned.

WO35/70-86 - RAID AND SEARCH REPORTS

These are reports of raids and searches that took place at various locations, such as private homes, pubs, hotels and factories across Ireland. Search orders recorded the address to be searched and what or who was expected to be there. The completed reports by military parties' detail what the search revealed, including the names of anyone found on the site (and if they were questioned or arrested) and what items of interest were uncovered, such as arms, ammunition or seditious material. For example, the records show over 70 search and raid reports looking for Michael Collins, the Irish Republican Army's director of intelligence.

WO35/57-58, WO35/68 - COURT-MARTIAL REGISTERS (MILITARY), DUBLIN, 1920 - 1922

This source contains registers of the military court-martial trials. The registers recorded the individual's rank, regiment, charge and verdict. Privates were brought before the court on charges such as theft, desertion and even physically assaulting a superior officer.

WO35/94-131, WO35/208 – CIVILIANS TRIED BY COURT-MARTIAL, 1920 - 1922

While Ireland was under martial law, civilians could be court-martialled under the Defence of the Realm Act. Reports pertaining to such occurrences contain statements about the offence and details of the court proceedings. In many files, you will also find witness testimonies and statements about the character of the individual on trial.

WO35/132-137, WO35/139 - COURT-MARTIAL CASE REGISTERS, JUNE 1916 - 1921

The registers contain the names of those who were tried by court-martial, charges against the individual(s), dates of offence, arrest, and court-martial, verdict, sentence and scheduled release date, and the particulars of the case.

Additional annotations, such as if the person went on hunger strike and/or died.

Additional notes also showed if the person escaped.

At the end of the registers are alphabetical lists of the prisoners and the page numbers where their trial details can be found.

WO35/138, WO35/140-144 - INTERNMENT CAMPS AND PRISONS, 1920 - 1922

These pieces contain the lists of those held in various internment camps and prisons. There are pages of reports for many of the detainees recording their charges, trial, and sentence. Further reports exist for those who were found to be innocent, released, or on a hunger strike in prison.

WO35/145-160, WO35/161-163 - COURTS OF INQUIRY

This source includes investigations into the deaths of prisoners, rebels, civilians, soldiers, or police between 1919 and 1922. The context of each death was documented with witness statements and coroners' inquests.

WO35/206 & WO35/207 - SINN FÉIN ACTIVISTS (A-E) AND (F-W)

These are intelligence folders from Dublin Castle about known Sinn Féin activists. The folders may include newspaper clippings about the individual, reports of movements, or arrests, as well as additional material seized in raids related to the individual.

WO35/88-89 - MILITARY OPERATION AND INQUIRIES

In these pieces, you will find military investigations and inquiries into ambushes, raids, reprisals, and other incidents. For example, within WO 35/88b is an investigation into the deaths of civilians at Croke Park on Sunday 21st November 1920.

The civilians were killed by the auxiliary branch of the Royal Irish Constabulary, known as the 'Black and Tans'.

The reports include the date and time of the incident, the names of those involved or present, and witnesses' statements. Piece 89 is a card index of reports organised by surname in alphabetical order.

WO35/90-93 - WAR DIARIES

War diaries are created by military units. They are not personal diaries or reflections on events of the day. They documented movements of patrols and units, any arrests made, and a summary of any additional events of the day related to military activities.

Most war diaries do not include many names unless it is an exceptional mention. Useful for tracking companies and battalion movements.

WO35/164-170 - CLAIMS FOR DAMAGES

These are claims for compensation for damage to properties or businesses by the British Army. Each claim will include the location of the damage, the date it occurred, and correspondence between the administration and the claimant about the investigation of the damage claim.

WO35/180 - COMMUNICATIONS

The communications pertain to military orders and movements, witness statements, and military nominal rolls.

WO35/181 - REBEL OUTRAGES: APPRECIATIONS AND MEDAL AWARDS

Lists of names of people who were awarded medals and awards for their actions in Ireland. The lists include name, rank, regiment, and where the person was stationed.

WO 141 & HO 144 - REGISTERED PAPERS

The registered papers are a compendium of military correspondence, court papers, prisoners' lists, maps, newspapers, as well as, inquiry notes into specific events. Specifically, series HO 144 will be of interest to those researching Irish history. The series contains the names of famous republicans including Arthur Griffith, Countess Markiewicz, Ernest Blythe, Thomas Ashe, Sir Roger Casement, and Sheehy Skeffington. You will find court martial reports, intelligence gathered from intelligence, and court papers.

UNITED STATES WWI DRAFT REGISTRATION CARDS

Perhaps the most important record collection for people with US ancestors who served in World War I is draft registration cards. These searchable records cover 24 million people and include information such as occupation, city of origin, birth date, and a signature. Three registrations occurred on the following dates:

June 5th, 1917, covering men ages 21 - 31; June 5th, 1918, covering men who had turned 21 during that year; and September 12th, 1918, covering men ages 18 - 45.

UNITED STATES, YMCA WORLD WAR I SERVICE CARDS, 1917 - 1919

This unique collection of over 27,000 index cards includes names of people who served with the YMCA (Young Men Christian's Association) - an organization that supported the troops by providing care to the sick and wounded as well as helping with other programs.

The cards include names, addresses, religious affiliation, army service and other information.

The men pose "Company Sergeant-Major Vickers, junior", a boy of five or six in guardsman's uniform, who salutes the camera. A line of officers, including French and Lloyd, watch. The King and Queen talk with Redmond. The battalion officers pose for the camera. The King and Queen leave to the officers' cheers.
